## Hangar Groundbreaking

Construction to Begin

The groundbreaking ceremony for the new \$14.8 million hangar for the 129th Air Rescue Wing was held October 11 at Moffett Federal Air Field. The ceremony, attended by many state and local dignitaries, was accompanied by the Air Force Band of the Rockies from Colorado Springs, Colorado. Colonel Tommy Williams delivered the welcoming remarks and was followed by MGen Gibson of OTAG, Dr. McDonald of NASA, State Assemblywoman Alquist, and the mayors of Sunnyvale and Mountain View. The AHA was well represented by board members. After the ceremonial groundbreaking with 'golden' shovels, the proceedings concluded with a fly over by a C 130 and HH60 helicopter. Construction should be complete in approximately 18 months.

## **Board Election**

March 2001

### **EANGUS**

Enlisted Association of the National Guard of the U.S.

**CCMS Alan D. Obermiller (Ret.)** 

The Enlisted Association of the National Guard of the United States has been in existence since 1970 and is a fully effective legislative entity with headquarters in Alexandria, Virginia. EANGUS is the only military organization that devotes 100% of its legislative resources and lobbying efforts to the enlisted National Guard soldier, airman, and retirees. No other organization represents the needs of the enlisted soldier and airman of the Army and Air National Guard exclusively.

It takes dollars and participation in the legislative process to put enlisted issues before the Congress every year. By law, the National Guard Bureau and the Department of Defense cannot lobby Congress, but associations can. EANGUS has the organization and recognition needed to become an effective voice on Capitol Hill. Now members are needed - members whose letters, e-mails, and telephone calls can educate and solicit members of Congress on issues affecting the National Guard and enlisted personnel.

Re-education of members of Congress is a neverending job. The percentage of legislators with military service has declined steadily and they must constantly be reminded who we are and what the National Guard represents to the Total Force - a large part of the total military capability available to the nation. The nation cannot fight a war without the National Guard. Service in the Guard presents special problems to enlisted personnel in the areas of civilian employment, lengthy deployments, adequate pay and allowances, medical care, etc.

We spend our careers looking out for our people and ourselves. Can we do less for those taking our places in the ranks? Can we leave to others our own needs as retirees? Remember leadership is an acquired skill that cannot be laid aside casually.

### **SPACE A TRAVEL**

A Brief How To

Space A travel can be an opportunity for those who are retired and inclined to travel about the United States or the world to do so in a relatively safe and inexpensive way. This article will acquaint you with some of the limitations and advantages of the system.

You can travel via military aircraft and stay in military guest/transit quarters for a fraction of the cost of civilian commercial transportation and lodging. However, you move and stay at the convenience of what is available at the time. Some of the limitations are very basic.

Only formally retired individuals can fly via the Space A system in the continental limits of the United States (CONUS). Dependents, including spouses, are not allowed Space A privileges within the U.S. unless the ultimate destination of the aircraft is outside CONUS. Hawaii and Alaska are excluded from this restriction.

Retired Space A travelers have the lowest priority. This is very difficult during summer months when active duty personnel are attempting leave travel with their families. Everybody in military air travel must have a designated seat on the aircraft regardless of age.

Each time you reach a termination point of your flight, you will have to reapply for the Space A opportunity to fly closer to your planned final destination.

These restrictions seem cumbersome at first, but as you learn the ropes, you will not only save a considerable amount of money, but will have experiences that become great memories.

## DONDI'S HANGB PASTA-MEAT SAUCE

½ oz dried Italian mushrooms
3 Tbsp. olive oil
¼ cup butter
2 (28-oz.) cans Contadina Seasoned Crushed
1 cup dry red wine
4 cloves fresh garlic, finely chopped
2 Tomatoes, w/Italian Herbs
2 Tbsp. dried Italian Seasoning
1 Tbsp. dried basil
1 Tbsp. dried oregano
½ Ib. Italian Sausage, ground
2-lbs. ground meat (beef, veal, or game)
1 cup dry red wine
4 cloves fresh garlic, finely chopped
2 Tbsp. dried Italian Seasoning
1 Tbsp. dried oregano
Salt & freshly ground pepper, to taste

Soak dried mushrooms in 2 cups of hot water until they are reconstituted, then strain through a cheesecloth lined sieve, retaining the strained liquid. Chop the mushrooms along with the other veggies. Melt butter with oil in a large saucepan. When butter foams, add onions, garlic, carrots, celery, and mushrooms. Sauté over medium heat until lightly browned. Add ground meat & sausage. Cook and stir until meat in no longer pink. Season with salt & pepper. Increase heat and stir in wine and reserved mushroom liquid. Cook until liquid has evaporated. Press tomatoes through a food mill or sieve to remove seeds. Stir tomato pulp into the meat/veggie mixture. Add all the spices. Cover and reduce heat. Simmer 1 to 1½ hours or until sauce reaches a medium-thick consistency. Stir occasionally during cooking to mix and prevent sticking. Makes 5-6 cups of sauce. Leftover sauce can be frozen.
