It is with deepest sympathy that I announce the death of Colonel Steven D. Friedricks, age 55, on 10 May 2008 in Thousand Oaks, California. Colonel Friedricks is survived by his wife Linda, daughter Jennifer, sister Kristy L. McConnell, and parents Robert J. and Mary M. Friedricks.

Colonel Friedricks was born in San Fernando,
California on 6 November, 1952. Upon graduation from
high school, Colonel Friedricks enlisted in the 146th
Airlift Wing in 1970 as an Air Operations Specialist,
assigned to the 195th Airlift Group. He was a
Command Pilot with more than 7600 military flying
hours. He was a foremost expert on employing the
Modular Airborne Firefighting System and flew many
missions suppressing California wildfires. Under his
inspirational leadership, the 146th Airlift Wing achieved
new heights in operational readiness and mission
accomplishment.



DeCA offers online dietician service

RANDOLPH AIR FORCE BASE, Texas (AFRNS) -- The Defense Commissary Agency has its own dietitian who is available to help the retiree community lose weight, get in shape and maintain good health.

Maj. Karen Fauber offers a weekly online column, "The Dietitian's Voice," and a discussion forum, "Ask the DeCA Dietitian" on the agency's Web site at www.commissaries.com/. Just click on the "Healthy Living" tab in the top navigation bar to find the link to the DeCA Dietitian page.

Visitors to the site will find suggestions for eating healthy, such as a variety of nutrition tips and meal choices. People can also submit questions to Major Fauber, and participate in an online forum to discuss healthy eating and shopping ideas.

Major Fauber is a registered and licensed dietitian with more than 16 years of military service, including experience as a certified diabetes educator in Army medical facilities and public health clinics. She earned a bachelor's degree in dietetics from Georgia Southern University and a master's degree in education and human development from George Washington University. The major interned at Brooke Army Medical Center in San Antonio, and is currently enrolled in an online doctoral program in health education through A.T. Still University in Missouri.

Air Force has new Web site for retirees

RANDOLPH AFB, Texas (AFRNS) – The Air Force has a new Web site just for its retiree community that is full of news and information, plus it is easy to access and navigate. The Air Force Retiree Services site is located at www.retirees.af.mil.

This public Web site offers the retirees family community in-depth information on the Survivor Benefit Plan, plus a list of Air Force Retiree Activities Offices worldwide and various other resources. There are also sections dedicated to the Afterburner and Air Force Retiree News Service.

Visitors can access the sections by using the top navigation bar on the home page. The home page also features the latest Air Force headline news and video clips. There is even a special icon for quick access to the Combat-Related Special Compensation information page.

Managing electronic subscriptions to the electronic version of the Afterburner and AFRNS is now much easier: just click on the word "Subscribe" found on the top navigation bar and unsubscribe an old address and then add a new one when a change is needed.

Five Years of VA Health Care for Combat Veterans

Military veterans who served in combat since November 11, 1998, including veterans of Iraq and Afghanistan, are now eligible for five years of free medical care for most conditions from the Department of Veterans Affairs (VA). This measure increases a two-year limit that has been in effect nearly a decade. The five-year deadline has no effect upon veterans with medical conditions related to their military service. Veterans may apply at any time after their discharge from the military, even decades later, for medical care for service-connected health problems. The new provision, part of the National Defense Authorization Act of 2008 signed by President Bush on January 28, 2008, applies to care in a VA hospital, outpatient clinic or nursing home. It also extends VA dental benefits, previously limited to 90 days after discharge for most veterans, to 180 days. Combat veterans who were discharged between November 11, 1998, and January 16, 2003, and who never took advantage of VA's health care system, have until January 27, 2011, to qualify for free VA health care. The five-year window is also open to activated Reservists and members of the National Guard, if they served in a theater of combat operations after November 11, 1998, and were discharged under other than dishonorable conditions.

As March came to an end, so did the Survivor Benefit Plan (SBP) Social Security Offset. As a result of Public Law 108-375, the Social Security Offset for annuitants was eliminated effective April 1, 2008. TRICARE Uniform Formulary Update Announced

Five additional, non-formulary (or third tier) medications have been added to the TRICARE Uniform Formulary. Three of the medications change to non-formulary status on April 16, 2008 - Exforge, Vyvanse, and Lybrel - and two on June 18 - Enbrel and Kineret.

Shingles Vaccine Covered by TRICARE, But Deductibles Still Apply

TRICARE covers vaccines as recommended by the Centers for Disease Control (CDC) and Prevention. For beneficiaries 60 and older, TRICARE now covers Zostavax, the vaccine designed to prevent shingles. TRICARE officials caution beneficiaries that "covered" doesn't necessarily mean "free." To view the full TRICARE Press Release, please visit:

Beneficiaries Nearing Medicare Eligibility Must Take Steps

TRICARE beneficiaries who are turning 65 and are eligible for premium-free Medicare Part A must enroll in Medicare Part B to remain eligible for TRICARE benefits, even if the beneficiary lives outside of the United States. Exceptions include when the sponsor is on Active Duty, the beneficiary is enrolled in the U.S. Family Health Plan, or the beneficiary is enrolled in TRICARE Reserve Select.
