Combat Awards

Eleven Airmen received the Distinguished Flying Cross and three airmen received the Air Medal at Moffett Federal Airfield, Calif., Nov. 5, 2011. 129th Rescue Wing Airmen from around the Bay Area heroically performed combat rescue missions in Afghanistan, often under hostile fire, in 2009 and 2010.

Because of these actions they received the Distinguished Flying Cross, a medal awarded to servicemembers who distinguish themselves in support of operations by heroism or extraordinary achievement while participating in an aerial flight.

Board Elections - Officers

March 2012

DFAS to Release 2011 Tax Statements via myPay and U.S. Mail

INDIANAPOLIS, Ind. (Nov. 29, 2011) – Electronic and postal delivery of 2011 tax statements for military service members, military retirees and federal civilian employees paid by the Defense Finance and Accounting Service will begin by mid-December through January with all customers receiving their W-2s and 1099Rs by January 31.

For most, tax statements will be available online using the DFAS *myPay* pay management system https://mypay.dfas.mil/mypay.aspx a week or more earlier than delivery via mail.

Military non-appropriate fund civilian employees receive tax statements from their respective military service. Army NAF employee tax statements are made available via *myPay*.

The *myPay* advantage While tax statements are available on *myPay* earlier than waiting for an envelope in the mail, there are other advantages to using the online system throughout the year.

Availability: Tax statements available on *myPay* will remain online for one year. These, as well as other documents such as leave and earning statements, may be printed or downloaded for storage on computer hard drives, CDs, DVDs or flash drives.

Except during periodic system maintenance periods, *myPay* is available 24 hours a day, 365 days a year. The only requirements are valid login credentials (ID and password) and a computer connected to the Internet.

The inner circle: *myPay* users have a need to allow trusted individuals to access their pay documents and information. Military members deployed away from home may wish to have their spouses, parents or other associates to retrieve information for tax preparation purposes. An elderly retiree may desire to grant access to his or her tax accountant or legal guardian.

Users can establish limited access passwords for their family members or other trusted individuals by logging in and establishing access in their Personal Settings. Individuals granted limited access to a *myPay* account may retrieve documents or view information but cannot make changes to existing addresses, bank accounts, allotments or other pay account information.

Security: While each pay account customer has a personal responsibility to keep their login information secure, myPay uses security tools that surpass industry standards to keep that customer's pay information safe. Recently, *myPay* was changed to allow customers accessing the system using a Computer Access Card (CAC) enabled computer to log in without using their login ID or password. This change made the system even easier to use while not compromising its security.

Savings: By using *myPay*, each military member, retiree and federal civilian employee saves their department or agency the cost of mailing documents. While each individual W2, 1099R or LES might be inexpensive, the overall costs of mailing millions of individual documents can become substantial. When combined with the environmental costs of paper, printing and delivery, using *myPay* is one way each individual can contribute to ensuring funds are available for their department's mission, such as supporting the needs of military men and women for DoD customers.

COMBAT BRAVERY

Crews' Heroics Hailed 11 Airmen Receive Distinguished Flying Cross for Afghanistan Rescue Missions

Their stories are so hair-raising and heroic that they sound like something straight out of a movie. And they're all the more compelling because they're true.

On Saturday, 11 members of the California Air National Guard's 129th Rescue Wing were awarded the Distinguished Flying Cross, one of the Air Force's highest honors, at their Moffett Field base in Mountain View for combat rescue missions, often under enemy fire in Afghanistan, during 2009 and 2010.

"It's definitely an honor," said Maj. Mary O. Jennings Hegar, one of the recipients. "When you're there, you're just doing your job. Every single person I work with would have done the same."

Her modesty belies the bravery she and her three crewmates showed July 29, 2009 when they flew their HH-60G Pave Hawk helicopter to rescue three wounded U.S. soldiers ambushed in Afghanistan's Kandahar Province.

As soon as they arrived, a bullet "spidered" the craft's windshield with a crack that sounded like a bat hitting a home run, Hegar said. Bullet fragments tore into her arm. After retreating a short distance to ensure the helicopter and crew could still fly, they returned — this time taking fire from a larger, belt-fed machine gun. Lt. Col. George G. Dona held the helicopter steady with guidance from Hegar as aerial gunner Tech. Sgt. TieJie Jones helped load the wounded. With guidance from Senior Master Sgt. Steven Burt and Hegar's critical move to switch from a leaking fuel tank, they limped their bullet-riddled helicopter a couple of miles away before setting it down.

Still under fire, Burt transferred the wounded soldiers to a second helicopter. Hegar, Dona and Jones then flew out on a smaller helicopter, standing on the landing skids and holding onto its rocket launchers. All survived.

"It was pretty Schwarzenegger," Hegar conceded with a smile, referring to the action-hero movie star who was California's governor at the time, while her 10-yearold daughter, parents and husband beamed with pride. Maj. Thomas W. Keegan was honored for purposely drawing enemy fire away from another rescue helicopter during a June 29, 2009 mission in volatile Helmand Province, allowing the other chopper to retrieve a wounded British soldier.

"One of our mottos is these are things we do that others may live," he said.

Lt. Col. Rhys W. Hunt, 2nd Lt. Andrew S. Hedin and Chief Master Sgt. Jason E. Red were sent to rescue five critically wounded U.S. Navy SEALs from the middle of a battle in Kandahar. Their team of helicopters came under heavy fire, including from rocket-propelled grenades, one of which exploded so close it rocked their ship. With Hunt at the controls, they returned fire. Red leaned out of the craft to keep his eye on their foes. Hedin sprayed additional gunfire that knocked out the enemy gunners. They were credited with saving the lives of 16 people as well as two helicopters.

Tech. Sgt. Luigge Romanillo distinguished himself during a May 4, 2010 high-risk mission to extract wounded coalition forces battling more than 100 insurgents in an ambush site near the Tagab Valley. The landing area was a small zone near the center of a contested village with hostile insurgents on the surrounding high terrain. The confined area required the helicopter to hover with the cargo door nearly five feet off the ground. With his aircraft taking fire, Romanillo and his teammate stepped into the firefight, and led his team through a hail of bullets to recover the patients. He was credited with administering lifesaving treatment and with the rescue of two wounded soldiers and recovering the remains of two others who were slain.

Senior Master Sgt. Larry I. Hiyakumoto and Staff Sgt. Joshua M. Webster distinguished themselves on an aerial flight near Bagram Air Field on June 27, 2010, when they participated in eight nonstop casualty evacuation missions over seven hours. On one, Webster was hoisted down from the helicopter to the soldier trapped below while under fire, while Hiyakumoto manned the aircraft's .50-caliber machine gun.

With rounds striking only feet from his position as well as the helicopter above, Webster quickly transported the wounded soldier to safety. While rounds were still striking the aircraft inches from his position, Hiyakumoto began treating the soldier for multiple broken bones and traumatic head injuries. The two saved 13 U.S. and coalition soldiers that day.

Also honored Saturday with the Air Medal were Maj. Mathew C. Wenthe, Capt. Hung D. Nguyen and Tech. Sgt. Joseph R. Kenney.
