### Affordable Care Act

Under the Affordable Care Act (ACA), all Americans including all military members and their eligible family members must have health care coverage that meets a minimum standard called minimum essential coverage or pay a fee. Your TRICARE coverage meets the minimum essential coverage requirement under the ACA.

Beginning in January 2016, DFAS will provide IRS form 1095-C to all US military members, and IRS Form 1095-B to all Retirees, Annuitants, former spouses, and all other individuals having TRICARE coverage during all or any portion of tax year 2015. An IRS Form 1095 documents you (and your family members, if applicable) have the minimum essential coverage.

The forms will document the information that DFAS will provide to the IRS on yourself and your authorized family members. The forms will be required to be reported with your 2015 federal tax return. DFAS will provide you with IRS Form 1095 no later than January 31, 2016.

### The Prez Sez

*The President's Column* COL John L. Ruppel, Jr. (Ret.)

The Annual Old Timers Lunch was held March 11<sup>th</sup> at Michaels at Shoreline Park with 120 attendees, the best attendance in three years. Twenty five members of the Wing attended the luncheon. Col Greg Jones, the new Wing Commander, spoke about his vision for the Wing and updated attendees on the Wing activates and the major construction projects. The recently approved 50 year lease and the acreage increase to 127 acres have proved the impetus for the milcon projects. The Wing has approval for a new motor pool facility and is awaiting approval for a new engine shop. The Air Guard site is completely fenced, and entry is now through a new \$225,000 gate off of the golf course perimeter.

Mr. Ron VandenBerghe and Mr. Robert Ceglio of Wells Fargo Bank, the principle donors, presented eleven Wing members with \$1,000 scholarships. This was the largest group to received Alumni Association Scholarships.

The Wing dedicated the new \$27 million Pararescue Facility on April 20th. Congresswoman Anna Eshoo assisted by Brig. Gen. Matthew Beevers, Deputy Adjutant General, and Col Gregory Jones, 129<sup>th</sup> Commander, cut the ceremonial ribbon opening the facility. The new facility will house the 131<sup>st</sup> Rescue Squadron and provide a modern operation and administrative facility for the assigned personnel. A number of Association members attended the ceremony and participated in the facility tour.

CCMSgt Doug Sale passed March 24, 2015. The family requested no electronic messages or obituaries. Doug served as the Medical Group Superintendent prior to retiring. He had been an Association Board member the last six years.

The Association was informed that Col Alvin Millspaugh passed November 24, 2014.

The Wing is entering the deployment cycle. The Alumni Association provided 210 Deployment Bags that will be distributed to deploying personnel. The bags contain a snack variety and a deck of cards to help pass the travel time. The Black Oak Casino Resort provided the playing cards. The Association has provided the bags since 2002 when the Wing commenced the deployment cycle.

There have been several Wing leadership changes and promotions. Col Jeff Magram, the Wing Vice Commander, was appointed Director of the Air Division Staff. Lt Col Daniel Lapostole will assume the Vice Commander position. Lt Col Jeff Richard, the Support Group Commander, and Lt Col Taft Aujero, the Operations Group Commander, were promoted to Colonel. Major Roxanne Toy, the Logistics Squadron Commander, was promoted to Lt Colonel. Roxanne serves on the Association Board.

Secretary–Treasurer Dave Russell and I appreciate the membership's prompt annual dues payments. The Board undertook a comprehensive review of the large membership dues delinguency over the last two years and the dues collection efforts. The Board decided to strictly enforce the two year delinquency rule. The decision resulted in a membership reduction from 304 to 284, which included adjustment from new memberships. The Association has received 94% of the 2015 dues assessment. A final notice is being sent to 20 delinguent members with a payment due date after which their membership will be terminated. The Board believes this will stabilize the membership, along with plans to seek more Wing memberships, and a program to solicit retiring or departing Wing members to join the Association.

## 129<sup>th</sup> RQW Dedicates New PJ Building

Members of the California Air National Guard's 129<sup>th</sup> Rescue Wing inaugurated a new building to house their Guardian Angel (GA) Squadron on Monday, April 20, 2015, with a ribbon cutting of the 48,750 square foot Pararescue Training Facility.

Construction began in January 2013 and was recently finished. The building will house the Wing's 131st Rescue Squadron. From arid deserts to snow covered mountain tops, from urban environments to rural setting, Guardian Angels (GAs) from the 131st Rescue Squadron can reach any destination by land, air or sea. The new Pararescue Training Facility at the 129th Rescue Wing will provide a modern operations and administrative facility for the GAs based here at Moffett Federal Airfield.

Based in the heart of Silicon Valley, the primary mission of the 129th Rescue Wing is to perform personnel recovery anywhere in the world. Equipped with MC-130P Combat Shadow aircraft, HH-60G Pave Hawk rescue helicopters and Guardian Angel teams, the 129th Rescue Wing performs a wide variety of civilian and military personnel-recovery missions, including the rescue of distressed persons aboard ships, lost or injured hikers, and medical evacuations. To date, the Wing is credited with saving the lives of more than 1,000 people. Guardian Angel (GA) is the U.S. Air Force's humancentric and equipment-based weapon system that executes all five tasks of personnel recovery (PR): report, locate, support, recover and reintegrate. GA consists of Combat Rescue Officers (CROs), Pararescuemen (PJs), and Survival, Evasion, Resistance, and Escape (SERE) Specialists. GA is considered the ground component within the USAF rescue triad, comprising the MC-130P Combat Shadow aircraft and the HH-60G Pave Hawk helicopter. As such, CROs and PJs deploy as teams into uncertain or hostile environments. They are trained to operate independently or in conjunction with rotary and fixed-wing aircraft, watercraft and overland vehicles, in order to locate, authenticate, and recover isolated personnel for return to friendly control. In addition to preparing personnel at risk of isolation, SERE Specialists conduct planning and execution operations across the full spectrum of Personnel Recovery.

# Capt R. Stephen Waldeck

1947 – 14 May 2015



Ralph Stephen Waldeck passed away at home in Woodland, May 14, 2015. He was born to Ralph and Dorothy Cranston Waldeck in 1947 in Woodland.

While at Woodland High School, Steve played basketball (a team captain); track and field where he won the Jay Sehorn Award for pole-vaulting. He was a quarterback at the first football game for the league championship against arch-rival Davis. Steve was amazed when he looked out at the crowd from the field, and remembered a "sea of orange" in the stands. Attendance for this game was estimated at 5,500. The Wolves beat the Blue Devils: 35 to 7.

During high school, Steve loved working at Cranston Bros for his favorite uncle, Eldon Cranston. They had the same personality and could make each other "crack up" by just glancing at each other.

Steve graduated from Chico State College, with Bachelor degrees in Science and Art and earned an MBA from Central Michigan University.

After college he joined the <u>US Air Force</u> in 1970 and received a regular commission in 1973. He flew helicopters for 11 years and piloted: Hughes 300, Bell H-12, Bell UH-1 and instructor-pilot on the CH-3 (Jolly Green Giant).

Steve's last 3 years of active duty assignment was with the 1st Helicopter Squadron of the United States Air Force based in Washington, D.C. His Squadron was charged with flying the Executive Branch, members of the Cabinet and foreign dignitaries.

After resigning his commission in 1978, at the rank of Captain, he returned to California and continued flying helicopters with the Air Force Reserve, assigned to the 129th Air Rescue Squadron out of Hayward, CA until 1981.

Steve taught Business Management courses at Woodland Center of Yuba College, and began his tax preparation business as an Enrolled Agent in Woodland.

Steve was a member of Woodland Lodge #81 Free & Accepted Masons and was elected Master of the lodge in 1995 and served as Treasurer since 1996, joined the Ben Ali Shriners and served as president of the Yolo Shrine. Steve was chairman "by acclamation" of refreshments for all parades that the Yolo Shrine participated.

He served as Treasurer to American Legion Woodland Post #77 and chairman of the Legion's County Fair Parking concession at Woodland Mall.

Steve acted as spotter/announcer for the Woodland High School football home games since 2001.

Steve drove a bright red Smart Car, and bragged that he had to fill the gas tank regularly once or twice a year. Steve loved JoAnn, family, his co-workers, his work and sitting on the deck at Shasta Retreat.

He is survived by his sweetheart of 32 years, JoAnn Wright. His children, Stephen B. Waldeck (Erika), Amanda Waldeck, Kelli Palmer (Frank) and Kyndell Wright-Hobson, and grandchildren: Nicole Waldeck and Stephen W. Waldeck, Madeline and Bryson Palmer and Korryn Hobson.

Steve is also survived by his brothers and sister, Gary Waldeck (Barbara); John Waldeck (Monica); Connie Beard (Bernard Hendrix); nephews, Nicholas Beard; Schuyler Waldeck-Myers, and Scott Waldeck; nieces, Karen Murvin; Kathy Chudakoff; and Mallory Waldeck; and was predeceased by his parents, sister, Joan Waldeck, brother-in-law Wallace (Larry) Beard, nephews Kenneth Waldeck and Christopher Beard.
